

## **Register of Media Service Providers**

Coimisiún na Meán is required to establish and to maintain a Register of Media Service Providers under the jurisdiction of the State under the Broadcasting Act 2009 as amended (the “Act”). The establishment of this Register is part of the new regulatory framework which transposes the Audio-Visual Media Services Directive.

Coimisiún na Meán (the “Commission”) is now publishing the first Register of Media Service Providers that are subject to registration under the Act. The entries in this Register are based upon the notifications submitted to, and decisions made by, the Commission on or before 9 November 2023. The information included in the Register in respect of each media service provider is mandated by Rules published by An Coimisiún on 4 May 2022.

The Register will be subject to changes and amendments on a continuing basis. Additional entries are likely to be made to the Register following the Commission’s consideration of notifications which have been received since 9 November 2023 and as a result of the receipt of further information regarding existing audiovisual on-demand media services.

The Commission has been conferred with statutory enforcement powers in respect of the registration process which includes, pursuant to section 46F of the Act, the power to issue directions to media service providers to take a specified action where it appears to the Commission that a media service provider has failed to comply with its notification obligations.
